Frassati Catholic Academy Tuition Contract Terms and Conditions - SY 2025-26

General Information

The payment of all prior years' tuition and fees must be current BEFORE registration will be accepted for the 2025–26 school year. This includes payment for EDP services. *No child will be permitted to start school in August unless all the prior years' tuition and fees, including EDP, have been paid.*

Tuition and Non-refundable School Fees

The non-refundable Registration Fee must be submitted at the time of registration. Failure to pay all tuition and related fees when due may result in your child(ren)'s exclusion from Frassati Catholic Academy, and Frassati Catholic Academy will take legal or collection action in order to collect these amounts from the responsible parties. Exclusion will begin on the first of the month, following the month of non-payment. *Please note all fees must be paid in full by the first day of school.*

Volunteering and Fundraising

PreK families are required to volunteer 10 hours per family throughout the year and participate in the annual Christmas Cash Raffle by selling 20 \$10 raffle tickets per family. K-8th families are required to volunteer 20 hours per family throughout the year and participate in the annual Christmas Cash Raffle by selling 20 \$10 raffle tickets per family. Options are available to "buy out" of providing service hours and selling raffle tickets on the Tuition Contract. If you have a preK student(s) and an elementary/middle school student, you are obligated to the K-8 fees and requirements only. Please note that families will be charged for any unworked volunteer hours at the end of the school year at the rate of \$15 per hour, which will be added to their FACTS accounts.

FACTS Information

- All new to Frassati Catholic Academy and RETURNING school families are required to use FACTS. Families will need to log into FACTS via our website, https://www.frassaticatholicacademy.org, click the FACTS link located on homepage under the QUICKLINKS dropdown. All families, including those who pay in full, MUST set up a payment plan within 10 days of receiving their Online Payment Plan Invitation.
- Returning school families who used FACTS last year will be eligible for 'Electronic Reenrollment' and will not need to create a new plan. If you wish to change your payment plan, please contact the school office at 847-526-6311.

- If you plan to apply for financial assistance for the 2025-26 school year, please submit your completed financial aid application forms via FACTS as soon as possible after completing your enrollment documents.

Frassati Family Association (FFA)

The Frassati Family Association (FFA), similar to a PTO, is a parent-led committee designed to support the school. The FFA will raise money through a **one-time family fee of \$75 for the 2025-26 school year**, as well as fundraisers and events throughout the year. Funds raised by FFA go toward assemblies, classroom supplies, teacher needs, school events, service projects, and school support. *Like school fees, FFA fees must be paid in full by the first day of school.*

PreK-8th Grade Extended Day Program (EDP)

Families with student(s) in grades PreK through 8th grade who choose to use our Extended Day Program (EDP) are required to pay an annual \$10.00 registration fee to use the program. This fee will be applied to the first EDP bill of the year. EDP is billed bi-weekly based on usage. Payment is due at the time families are billed. Any past due balances from the previous month will be rolled into your FACTS account automatically. The EDP is available daily 6:30am – start of school and after school until 6:00pm. The rate is \$6/hour/child, billed on a bi-weekly basis.
